



SESSIONAL CLINICAL LECTURER

The Leslie Dan Faculty of Pharmacy, University of Toronto, invites applications for the position of Sessional Clinical Lecturer to co-coordinate a mandatory course, **PHM206H1 Medication Therapy Management 3 (MTM 3)**, which is scheduled in the winter term of the second year of the Doctor of Pharmacy (PharmD) program. The position is offered from October 15, 2020 until May 31, 2021.

This second year course is the third course in a four-part course series that is delivered longitudinally over three years of the PharmD program. It builds on the skills developed in previous MTM courses (MTM1 & MTM2), offering students opportunities to apply and integrate materials learned through all courses in the curriculum to date. This course focuses on the development of skills required for both hospital and community pharmacy practice. Lectures and applied simulated practice sessions emphasize the pharmacist's role and responsibilities as a communicator, care provider, collaborator and advocate to prepare students for APPE rotations. The course will be taught using a variety of techniques including lectures, case-based learning, virtual interactive cases and standardized patient simulations. Due to the uncertainty with COVID 19 there is a high likelihood that this course will be delivered virtually via the online platform zoom, or as a hybrid of online and in-person activities.

The expected enrollment for this course is 240 students. Clinical Instructor support is provided for case-based interactions and assessments.

Applicants should be a licensed pharmacist. Candidates must have experience in a clinical practice setting within the Canadian Health Care system. The successful candidate must demonstrate excellence in teaching, currently practice in, and demonstrate a strong knowledge of the relevant field, and, possess excellent organization and communication skills. Experience in the development and delivery of courses is an asset, including online course delivery. Strong clinical and technological skills are assets.
