Summer Course: Combatting Corruption and Promoting Equity in the Health Sector

This course on good governance and transparency in medicines was developed by **Dr. Jillian Kohler** (WHO CCGAT Director) and **Dr. Tim Mackey** (University of California) in collaboration with the WHO/EMP. This course includes course faculty from the WHO, PAHO, and Headquarters and be open to students at the University of Toronto as well as international students. This course is mobile and depends on the interest of regional and country counterparts and other Collaborating Centres. The WHO helps provide input and select participants to this course. Ideally, this course will also be offered overseas every two years and where funding is available, course material will be translated. We envision this course to be part of knowledge sharing and collaboration on research and training areas of mutual interest with other WHO Collaborating Centres.

This year, the summer course was given at the University for Southern California – San Diego. Through a masterclass, lectures, case studies, panel sessions, and a group change design workshop with leading global experts from the WHO CC, USAID, UNDP, and the World Bank, participants learned about how corruption manifests in the health sector, how it undercuts health and equity goals, and how anti-corruption, transparency and accountability (ACTA) strategies can be used to mitigate corruption in the health sector.

September – November 2018

Course: Diagnosing Corruption in the Health Sector and Anti-Corruption Policies and Tools



This course was developed by **Dr. Jillian Kohler** (WHO CCGAT Director) and approved by the Leslie Dan Faculty of Pharmacy Curriculum Committee in June 2018. It was cross listed with the Munk School of Global Affairs and Public Policy and the Dalla Lana School of Public Health at the University of Toronto. The course was offered to graduate students across the University of Toronto for the Fall 2018 term.

The course introduced students to the core concepts associated with corruption and corruption within the health sector, with a specific focus on the pharmaceutical sector. Students learned the characteristics of corruption and how it manifests in the health and pharmaceutical sectors, the various anti-corruption, transparency, and accountability strategies used by international organizations to address corruption, and the strengths and weaknesses of schools of thought in the corruption and health literature and policy.

Students were evaluated on course participation, a research paper, and a presentation related to their research. The research paper and presentation provided students the opportunity to further probe an area of interest.
