Deanna Williams graduated from the Faculty of Pharmacy in 1976. She joined the Ontario College of Pharmacists (OCP) in 1994 as Director of Programs. Deanna was appointed as Deputy Register in 1998 and as Registrar in 2000. This award was established in recognition of her service to the OCP and to the profession of pharmacy.

The Deanna Williams Award will be given to a student registered in the Fourth year of the Doctor of Pharmacy program at the Leslie Dan Faculty of Pharmacy who has:

- Demonstrated innovative leadership in a pharmacy-related setting;
- Demonstrated the likelihood of a noteworthy future contribution to the profession and a commitment to continuous learning;
- Attained at least Second Class Honours (i.e., an annual Grade Point Average of 2.70 or higher) in each of Years 1, 2 and 3, and Pass standing in all Year 4 courses.

The recipient must be eligible for financial assistance under OTSS guidelines (i.e., the recipient must be an Ontario resident, must be a Canadian citizen or Permanent Resident, and must have received either OSAP funding or financial assistance from the Faculty in the session of application).

The award will not be given if a suitable candidate is not identified.

Approximate value of the award: \$2,500
