Established at the Leslie Dan Faculty of Pharmacy at the University of Toronto in 2015, the WHO CC assembles leading governance and related experts who partake in critical research and policy work on issues relating to accountability, transparency, and governance in the pharmaceutical sector on the global problem of corruption.

The key objectives of the WHO CC are:

- To utilize existing research facilities at the University of Toronto for research and policy analysis and training on issues related to the pharmaceutical component of health systems anticorruption, transparency, and accountability (ACTA) in collaboration with the WHO.
- To bolster the global dissemination of knowledge on issues related to the pharmaceutical component of health systems ACTA.
- To support collaboration and help intensify the work of the WHO with respect to the pharmaceutical component of healthy systems ACTA.

This past year, once again, the WHO CC Fellows produced tremendous knowledge on ACTA issues as the report highlights. The WHO CC also continued its commitment to disseminating knowledge through online webinars, research seminars, and virtual workshops which has allowed us to reach a wider audience and strengthen our virtual community and global reach. We hosted numerous webinars that featured fellows, international and national speakers and were centered around a variety of subjects including corruption risks in the deployment of COVID-19 vaccines, the opioid crisis and understanding compliance risks within the pharmaceutical industry, as well as a workshop on Governance, Leadership and Transparency in Pharmaceutical Sector Procurement for the EAC Regional Centre of Excellence for Vaccines, Immunisation and Health Supply Chain Management in Rwanda.

<u>Details</u>: Dr. Sheryl Spithoff is an Assistant professor in the Department of Family and Community Medicine at the University of Toronto, and a staff physician at Women's College Hospital. In this seminar, she will present research findings from her research team's study examining the privacy- related ethical implications of Canada's direct-to-patient commercial virtual care industry. Commercial virtual care expanded with the Covid-19 pandemic, providing rapid access to medical services. Through analysis of interview data and privacy policy documents, her research team concluded that commercial virtual care in Canada enables widespread commercial use of health data, permits patient surveillance, and presents risks to privacy and autonomy. These risks may disproportionately affect structurally marginalized groups and communities.
