PharmD Program

2.2 Meeting of March 27, 2023

PharmD for Pharmacists Program

The PharmD for Pharmacists Program Committee reported:

- A clarification in grading in PHM618H1 Educational Theory and Practice where students will be responsible for discussion posts for an EDI in education topic.
- Minor changes in content in PHM652H1 Contemporary Therapeutic Issues in Primary Care where the topic of non-cancer pain will be removed and dermatitis will be added.

PharmD Program

The PharmD Program Committee reported:

- A change in grading policy in the Early Experiential Experience (EPE) courses to align with the Advanced Pharmacy Practice Experience (APPE) grading policy.
- New requirements for the Global U Certificate Program. Students must complete either:
 - Requirement A:
 - PHM320H1 Global Pharmaceutical Policy or PHM325H1 Indigenous Issues in Health and Healing, and;
 - PHM387H1 Global Health or PHM389H1 Research Project, and;
 - One APPE rotation.
 - o Requirement B:
 - PHM320H1 Global Pharmaceutical Policy or PHM325H1 Indigenous Issues in Health and Healing, and;
 - Two APPE rotations.

These changes will provide students with flexibility in meeting the learning outcomes of the Certificate and allows for a learning path more targeted to their interests.

2.3 Meeting of April 24, 2023

PharmD for Pharmacists Program

The PharmD for Pharmacists Program Committee reported:

- Course exemptions for students enrolled concurrently in the PharmD for Pharmacists Program and the
 Master of Science in Pharmacy (MScPhm) program, to include three didactic courses for which
 comparable courses were completed in the MScPhm, and two APPE rotations in recognition of the 8
 months spend in clinical practicum in the MScPhm program. This represents fewer than 25% of the
 curriculum. Students will continue to complete 8 courses and 2 APPE rotations to achieve the PharmD
 degree.
- Minor grading change in PHM653H1 Contemporary Topics in Oncology.

3.0 Other Business

Nominations and applications for next year's (September 1, 2023, to August 31, 2024) Leader in Residence (LiR) are now open. This program was designed to bring leaders in pharmacy and pharmaceutical sciences

closer to the Faculty & engage more directly with students to create a culture of management & entrepreneurship.
