4.0 Proposal for New EDU-C Relating Health Care Impact on Climate Change

FOR APPROVAL

Guest F. Miller presented the proposal for a multi-disciplinary Extra-Departmental Unit (EDU) Type C to be established called the **Collaborative Centre for Climate**, **Health & Sustainable Care** ('the unit'), effective November 1, 2023.

• The unit will advance research and education, as well as application and impact in clinical care, health system management, health policy, and public health to meet the transformative challenges posed by global ecological change, and its social and structural determinants and sequelae.

• The unit will leverage the core strengths of its four founding health science faculties – the Dalla Lana School of Public Health, the Temerty Faculty of Medicine, the Lawrence S. Bloomberg Faculty of Nursing, and the Leslie Dan Faculty of Pharmacy – and engage interested faculty and trainees across all University of Toronto divisions.
